

HDPE MIX NATURAL / COLOR - Bales

COMPOSITION & QUALITY STANDARDS

HDPE #2 mix natural / color bottle bale (previously known as “80-20 bale”) is expected to contain: 80% laundry detergent, shampoo, bleach and other household cleaning bottles, white & yellow milk bottles, as well as HDPE jars, canisters, and squeeze tubes and 20% natural 1-gallon, food grade, milk & water jugs . We also will accept LDPE lids because we prefer them In the HDPE color bottle bale rather than the PP bale. All containers should be blow-mold only.

Bales may measure 3x4x5, 4x6x4 or other standard size and should be secured with 10/12 gauge galvanized baling wire or other non-corroding strapping to prevent discoloration / oxidation of HDPE. Bales should not be stored outside uncovered longer than four weeks prior to shipment. No cardboard headers.

CONTAMINANTS

Loads shall not contain in excess of 2% contamination. Examples include:

- Any plastic not of the specified type, i.e., PET (#1), PVC (#3), PP (#5), Other (#7) bottles; film
- Injection grade plastic, even if marked HDPE (any wide mouth containers such as buckets, crates, margarine containers, lids or chemical bottles). There are separate specs for this bulky rigid material.
- Any other material that is not plastic i.e., aluminum cans, cardboard, paper, liquids, etc.
- Plastic that has deteriorated due to sunlight or weather exposure.
- Excessive amount of debris (sand, rocks, dirt, etc.) or moisture
- Heavy baler residue, grease or grime is subject to rejection.

REJECTIONS & PRICE ADJUSTMENTS

Material purchased not meeting quality standards so as to render material difficult to process or completely unmanageable will be subject to price adjustments or rejection. If a load or partial load is rejected due to non-conformity to the specs, then the material supplier shall be responsible for any and all additional costs resulting from the rejection of such load including but not limited to in-bound/ outbound shipping, demurrage, additional labor charges, landfill fees and other associated costs. Arrangements to pick-up or return rejected material must be made in a timely manner to avoid additional demurrage charges. All prices are FOB selling point unless otherwise agreed. PO price, unless stated on the PO, is for a truck load weight of 40,000 pounds (see below). All trucks are weighed empty and full, at KW, on scales calibrated to 10 lbs. increments. KW weights will govern settlement. A PO is for a single load of material and is be provided to each customer. Settlement papers and a weight ticket will be provided for each load. Price reductions/freight charges will be made accordingly:

40,000 lbs.+	base price
34,999 – 30,000 lbs.	base price minus \$0.01/lb.
29,999 – 25,000 lbs.	base price minus \$0.015/lb.
24,999 – 20,000 lbs.	base price minus \$0.025/lb.
19,999 – 15,000 lbs.	total freight
